- a. Someone living in the Netherlands selling Dutch cheese via www.kaas.nl
- b. An American company using a server located in the Netherlands to host their website Newsoftheworld.com
- c. A Japanese firm selling Dutch wooden shoes via dutchwoodenshoes.eu
- d. A Dutch firm selling windmills to the South American market via the website <a href="https://www.windmills.ar">www.windmills.ar</a>

## **Question 2**

The national secret service has tapped your e-mail because you have visited Afghanistan last summer for a ATB-tour. Is this action in accordance with article 8 of the European Convention on Human Rights? Motivate your answer when it is allowed and when and why this is not allowed.

#### **ARTICLE 8**

- 1. Everyone has the right to respect for his private and family life, his home and his correspondence.
- 2. There shall be no interference by a public authority with the exercise of this right except such as is in accordance with the law and is necessary in a democratic society in the interests of national security, public safety or the economic well-being of the country, for the prevention of disorder or crime, for the protection of health or morals, or for the protection of the rights and freedoms of others.
